




#### **NOKUT - the Norwegian Agency for Quality Assurance in Education**

- NOKUT was established in 2003 as a result of the Bologna process and the quality reform of higher education in Norway.
- NOKUT is an administrative body under the Ministry of Education and Research, professionally independent.
- NOKUT accredits, supervises, evaluates and informs about and contributes to developing the quality of Norwegian education programs and institutions. Both higher education and higher vocational education (tertiary).
- NOKUT's work shall contribute to society's confidence in the quality of Norwegian higher education and higher vocational education.

# Many new regulations within higher education and higher vocational education

- New accreditation requirements for university status
- For the first time, legislation allows for institutional accreditation of vocational colleges

New regulations for the accreditation of university colleges, scientific university colleges and universities were adopted in December 2024.

Work has also begun on regulations for the accreditation of bachelor's, master's and doctoral degree programmes, which will continue in 2025.


NOKUT has updated its guidelines and methodology and held seminars and information meetings for the sector.

## Periodic review of institutional quality assurance practices in HE

**2004:** Internal systems for QA of higher education where required by law

**2003-11**: First cycle: Evaluation of QA systems (76 institutions)

**2009-16:** Second cycle: Evaluation of QA systems (62 institutions)

**2017-24:** Third cycle: Periodic follow-up of institutional quality assurance practices (48 institutions)

**2025-2031:**Fourth cycle starts in 2025





## The vocational college sector

- The vocational college sector has grown significantly
- NOKUT has received a massive influx of requests from vocational colleges to accredit study programmes, resulting in long queues
- In May, an amendment was made to the Vocational Colleges Act allowing institutions to apply for institutional accreditation

## The National Student Survey (2013-2025)

- A national student survey that is sent to more than 75 000 students in higher education (each autumn since 2013) and 23 000 tertiary vocational school students (each spring since 2017)
- Asks for the student's perceptions of educational quality in their study programs
- The purpose is to strengthen the quality work in higher education and give useful information about educational quality
