- The objectives are:
  - o To learn from each other
  - o To marked the NOQA HE area as a professional region in Europe (ENQA report)
  - o To strengthen the Nordic Networking

#### **WORKING TITLE**

How a focus on learning outcome may strengthen the external quality assurance of higher education

Investigating and discussing Nordic practices and developments

#### AIM OF THE PROJECT

To collect and analyze comparable data about the agencies approaches to learning outcome with the aim to support developments in the agencies methods, criteria and/or documentation.

#### **FRAMEWORK**

- 1. Project group consisting of 1-2 members from each participating agency
- 2. A design that supports active contribution at an equal level from each participating agency
- 3. Content of the project is directed solemnly towards the agencies own practices on the topic of assessing quality assurance
- 4. Intermediate status report on the general design of the project containing actions and a timeline that ends with a "Full stop" at the next annual meeting
- 5. Intermediate report II, a draft report that allows the management in each agency to decide upon the content
- 6. Report of a quality that may be accepted as an ENQA publication an a continuation of the former report on the same topic
- 7. Report completed ("full stop") at least two weeks before the next annual meeting; 3. and 4. June 2013
