5. Developing terms of reference for the joint Nordic project 2013-2014

General discussion on the joint Nordic projects and co-operation:

- The duration of the projects could be longer than one year (to avoid too tight schedules in projects)
- NOKUT is celebrating 10 years anniversary the next meeting could be linked to the NOKUT's anniversary seminar
- Proposals for the next joint project: risk-based approaches and models, learning outcomes (to continue the project started in 2012), co-operation with Baltic colleagues, exchange of experts/ staff exchange

Based on the discussion the following two projects were decided to be launched:

- 1. Forum for staff exchange
 - Leading: Christian and Karin
 - The aim is to establish a forum to exchange experiences
 - The framework and focus areas of the staff exchange will be planned by a project team (examples of the focus areas: evaluation methodologies of the agencies, site visits)
- 2. NOQA seminar in Sweden in co-operation with the Baltic network of quality assurance agencies
 - Leading: Hannele (seminar arrangements in co-operation with Universitetskanslersämbetet)
 - Date of the seminar 12.-13.6.2014 (another option 2.-3.6.2014)
 - FINHEEC will contact to Baltic agencies in June and ask their willingness to have a joint seminar of Nordic and Baltic quality assurance networks
 - Planning team will prepare a proposal for the seminar programme (e.g., themes of the seminar, guidelines for the presentations, group works etc.) and it will be send for comments to agencies
 - Agencies will nominate the members to the both staff exchange and seminar planning teams in September
